## Privacy policy of the Intersurgical website

## Non-personal information collected automatically

Intersurgical Ltd. (hereafter referred to as Intersurgical) is committed to the protection of the privacy of its web site visitors. Please note that we monitor statistics about our users, traffic patterns, and site performance information, but these statistics are not shared with third parties and do not include any 'personal information' (for more information, please see section "Visitor identification & How we use Cookies").

## Personal information

This site may use technology that lets us collect certain technical information like your IP address, your browser type, the address of Intersurgical website that you opened and the time when you viewed this site. This information is used for solving incidents and errors on the website and is kept for 6 months after your visit to the website and irreversible deleted after that.

We also use Google analytics on the website for improving our products and services. We use Google Analytics provided functionality for IP Anonymization. Intersurgical also uses the Lead Forensics Product on our websites for sales and marketing. This software works on the basis of reverse business IP tracking. A small tracking code is placed on our website(s) which then enables us to identify the business IP addresses of our website visitors. The information collected by this software on Intersurgical websites is limited to business IP address, browser type, device type, date and time of the visit. Business IP address is then matched to a database of business points of contact, presenting this information to its customers as potential contacts from the visiting organisation (provided by Lead Forensics on an additional purchase basis). The session key stored in the session cookie contains only a random number identifier that is used to index the server's session cache, there is no other information exposed in the session cookie. This cookie is required for proper website functionality and expires when the browsing session ends.
Security	_RequestVerificationToken	This is an anti-forgery token, which guarantees that the request is made by the user. This cookie is required for proper website functionality and expires when the browsing session ends.
Preferences	cc_bar	In order for us to recognise that you have been informed about our cookies policy or that you have opted out from cookies, we have to place our cookie on your device so we can know not to set other cookies the next time you visit. This cookie is required for proper website functionality and expires after one month.
Google Analytics cookies	_ga, _gat, _gid	The main purpose of these cookies – performance of the website, used to distinguish users. IP addresses are anonymised. These cookies are optional and they expire after one month (_gid), 2 years (_gat) or when the browsing session ends (_ga).
